Minutes of the General Meeting April 11, 2012

Post Commander Keithly called the meeting to order at 1855 hours. The following officers were present: Post Commander Keithly, 1st vice Commander John Pearson, Adjutant Terry O'Keeffe, Post Service Officer Rob Garrison, Sgt. at Arms Ed Bulgin, and members at large Archie Banbury and Jack Knoblock. There were thirteen additional members present.

The minutes from the General meeting of March 13, 2012 had been previously distributed to the membership. The motion was made by Jack Knoblock and seconded by Rob Garrison to approve the minutes as submitted. The motion passed.

Finance Report

The Post Commander made the financial report. The Finance Officer had provided a cash report dated March 31, 2012 (see attachment). \$1000 has been transferred from the Veterans fund to the Operating fund to allow for upcoming expenses. The funds will be returned as soon as we have more income. The Finance Officer will be making a profit and loss statement to the membership on a monthly basis. As of the end of March the Post has a total cash balance of \$20194.88.

Adjutant Report

Terry O'Keeffe reported the Post membership stands at 176 and 152 having paid their 2012 dues. The American Legion, Idaho Department is currently holding funds for Cascade Post 60 derived from on-line membership renewal. The Adjutant will contact Department and to find out who made that decision to hold the funds in Department and what are the plans for these funds.

John Pearson reported volunteer sign-ups for upcoming events were going well.
